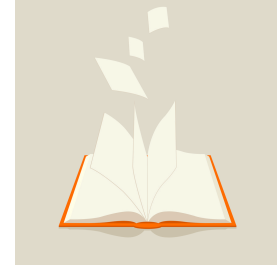

The Kathleen Wilbur School will implement programs, activities, and procedures in its Title I program in compliance of Sections 1111, 1112, 1116, and 1118 of the Elementary and Secondary Education Act (ESEA). These guidelines will be developed jointly with parents of participating Title I children and will be reviewed annually.

Statement of Purpose:

The faculty of our school is committed to providing a quality education for all students and to recognizing the essential role of parents and the value of their input.

1. School staff will carry out regular, two-way and meaningful communication to provide additional information to parents and to increase parental involvement in supporting classroom instruction. There will also be opportunities throughout the school year for parents to review and amend the Title I documents with parent-friendly wording.

- The school will distribute a newsletter to parents that includes school news, a calendar of school activities, and parenting tips relating to school achievement such as homework tips, organizational skills, and study skills.
- The school has its own web site which houses a website for each grade level. Pertinent information will be available on those websites. Also, parents can access their child's progress information using the DSC Parent Portal. Parents may use e-mail to communicate with members of the school staff. - Each teacher will send home a folder containing student papers and work samples each week.
- The school will provide parents with report cards every nine weeks with information regarding their child's academic progress.
- The school will send text alerts and email updates and post notices on the school website with information about parent workshops and meetings. If you have not yet registered for the text alerts, please text @WBParents to 720-924-4738.
- The school will provide, whenever practical, pertinent school information in the parents' native language.

2. The school will hold parent meetings, conferences, and activities regularly throughout the year to increase parental involvement.

- These meetings will include a family reading night that provides an opportunity for parents and their child to experience the school situation.

- Teachers will hold individual conferences with parents of children in their classrooms.
 - The school will engage parents in the following types of roles and activities to increase their involvement and support for student learning:

 - 5) Award's day presentations

- 3. The school will work with the Parent Input Committee to create a School-Parent-Student Compact.**
- School staff and parents will develop a school-parent-student compact. This compact will outline how parents, school staff, and students share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the state's high academic standards.
 - Compacts will be filed and maintained by the school annually.
- 4. The school will provide an opportunity for parents to engage in decision-making processes in regarding the school's Title I, Part A program.**
- The school will engage parents in decisions about the allocation of its' Title I, Part A funds for parental involvement.
- 5. The school will maintain an area as a resource center for parents.**
- Parents will be encouraged to view the Title I Plan located in the school library. A suggestion sheet will also be available for parental input.
- 6. The school will engage parents in an evaluation of parental involvement efforts.**
- An online survey will be maintained and parent responses will be analyzed.
 - The Parent Input Committee, made up of teachers, parents, and school staff, will determine the effectiveness of the parental involvement plan and make changes if warranted.
